IFLA ASIA-PAC LA LUMINARY AWARD 2017



The International Federation of Landscape Architects (IFLA) Asia-Pac LA Luminary Award, is IFLA Asia-Pacific's inaugural and highest honour accorded to its regional luminaries who have inspired and made significant contribution in protecting, championing, advocating, enhancing and/or sustaining the living environment and communities in their profession, region, countries or cities. This award is held in conjunction with the IFLA Asia-Pac LA Awards.

NOMINATIONS AND SELECTION PROCESS

This category is open for IFLA Asia-Pacific National Association's nominations. The Award recognises leadership, stewardship and commitment across all design and professional disciplines, including Planning, Engineering, Social Science, Policy, Research, Politics, Communications and Journalism; Architecture and Urban Design; and Landscape Architecture.

It aims to recognise exemplary individuals and distinguished luminary for their achievements and contributions in building healthy communities, environmental sustainability and enhancing cities liveability.

An appointed panel of independent, expert jurors from both local and international will assess potential Award candidates.

Award Recipients will receive a trophy and a certificate at the IFLA Asia-Pac LA Awards Ceremony in November 2017 and will also be featured in IFLA Asia-Pac LA Awards publication.

The Distinguished Luminary will also be conferred Patron title under IFLA Asia-Pacific region.

The Award is administered by the International Federation of Landscape Architects (IFLA)Asia-Pacific.

Nominee Eligibility

The nominee does not need to be a member of IFLA or landscape architects. He/She can be in any profession as long as he/she meets the criteria to be nominated.

Submission Guidelines

To nominate an individual as IFLA Asia-Pac LA Luminary, the official entrant must be a Full or Corporate member (or equivalent) of its national associations under IFLA. Any entrant who is not under its national association, IFLA Asia-Pacific region or IFLA is NOT ELIGIBLE for submission.

All entries completed with the Official Registration Form and Project must be submitted to <u>iflaapr.laawards@iflaonline.org</u> via dropbox or any file hosting service/online file storage provider.

Submission: Materials in the submission is in Word document format not more than 2 pages of Arial font type and font size of 11. Name of the entrant and IFLA National Association shall be indicated in the registration forms.

Criteria for Nominee: The jury will consider the body of works contributed by the nominee to the society, communities and the environment. It will assess the positive outcomes and the kind of influence it has made to bring values to the field of landscape architecture and the living environment.

Nominee Name and Title (Name): A submission must have a full nominee's name and title (containing no abbreviations) that indicates the occupation and designation.

Distinguished Luminary Statement: In 300 words or less, described the nominee and why he/she is exemplary and distinguished in their contributions an in their own rights. This statement may be used in promotional materials if the project is selected for an award. NOTE: failure to submit this statement will lead to disqualification of entry.

Narrative for Nominee: Addressing the criteria for the Luminary category, describe in 1300 words or less any leadership, stewardship, service and commitment across all design and professional disciplines, including Planning, Engineering, Social Science, Policy, Research, Politics, Communications and Journalism; Architecture and Urban Design; and Landscape Architecture. This should also include any body of works in media or publication to support this nomination.

Electronic Boards: To facilitate the printing of A1 boards for the exhibition at Awards Ceremony, participants are required to compose and include ONE layout board. Each board should be in original A1 size, in landscape format and in high resolution of 300 dpi.

Images*: All images/photographs used in the Project binder and Electronic boards must be placed in the Image folder (high resolution) in .jpg, raw, or tiff format; technical drawings can be .pdf format. Nomination images must include at least one (1) clear front view portrait and up to three (3) images and/or photographs not to exceed 10 MB. Brief captions of no more than 40 words each are to be placed at the bottom of each image. NOTE: failure to submit images will lead to disqualification of entry.

Recognition: The Professional Awards Jury may each select any number of Distinguished Luminary Award in this category. Jury may choose to confer special award or special titles or recognition not stated in the awards categories.

Dates of Awards Ceremony

Recipients will be honoured at the awards presentation ceremony at the IFLA Asia-Pacific Regional Congress and Annual General Meeting on November 2-5, 2017 in Bangkok, Thailand. More details will be available at a later stage.

Submissions Review

The Awards Jury will review all nominations in June, 2017.

Notification

Entrants will be notified of the results shortly after the final review.

Announcement of winners

The awards will be announced to the media following notification of and coordination with the recipients.

Panel decision

The decision of the Panel is final and shall not be negotiated, contested, reviewed, challenged or appealed against by any party though any means or process whatsoever. The discretion of the Panel to make or withhold without an award is absolute

Publishing Rights

All nomination entries are the property of the IFLA and all entries will not be returned to the participants. The organiser shall reserves the rights to publish, display, exhibit, reproduce or otherwise publicise or communicate all entries submitted, subjected to appropriate citation and acknowledgement of the authors without putting the organisers under any obligation whatsoever.
